I write regarding the above planning and listed building applications for new entrances and alterations to the Institute of Contemporary Art.

Remit: The Theatres Trust is the national advisory public body for theatres. We champion the past, present and future of live theatre, by protecting the buildings and what goes on inside. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015 requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment: The Theatres Trust does not object to this application, however, we do have hesitations about the loss of the studio theatre space. We generally support the concept of reconfiguring the existing rooms within the podium to create a large, adaptable space at ground floor level which can be divided into smaller spaces as necessary, and recognise this flexibility will be beneficial to the ICA's current programme requirements.

However, while live theatre may not be a regular part of the current ICA programme, it may be once again in the future, and we would therefore recommend the existing dressing rooms/ back of house spaces are retained (or relocated) to continue to facilitate live theatre now and into the future. It is also unclear from the plans provided where and what the temporary room dividers are, where and how they are stored when not in use, or if they are of a suitable material for noise mitigation to allow for simulations events.

While we do not object, we do recommend further consideration be given to the above comments, particularly the retention of dressing room facilities to safeguard future theatre use.
