Theatres Trust Annual Return

Please find below the details of the Theatres Trust's Annual Return for the 01 April 2016 to 31 March 2017 reporting period.

Background

Under the provisions within the Planning and Compulsory Purchase Act 2004, Planning (Wales) Act 2015, and the Town and Country Planning (Development Management Procedure) (Wales) Order 2012 (as amended in 2015 and 2016), the Theatres Trust, as a statutory consultee, is required to submit an annual return to the Welsh Government to report the timeliness and number of substantive responses provided by the Trust to pre-planning and planning application consultations.

Theatres Trust consultee status

The Theatres Trust is the National Advisory Body for Theatres. We were established by The Theatres Trust Act 1976 and The Theatres Trust (Scotland) Act 1978 'to promote the better protection of theatres'. These Acts apply to all theatre buildings in Scotland, England and Wales. Our 15 trustees are appointed by the Secretary of State for Culture, Media and Sport.

The Theatres Trust delivers statutory planning advice on theatre buildings and theatre use through the Town and Country Planning (Development Management Procedure) (Wales) Order 2012, Schedule 4, Para (r), (as amended in 2016) which requires the Trust to be consulted in relation to planning applications for Development involving:

(i) any land on which there is a theatre;

(ii) residential development (excluding householder development) within 50 metres of a theatre (not falling within paragraph (i)); or

(iii) a proposed theatre.
