Proposal: Listed building consent for flat roofing replacement works to (new section) of building, basement structural remedial works and minor maintenance works to front and side elevation comprising of window repairs and decoration

Remit:

The Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment:

Thank you for consulting Theatres Trust regarding this proposal which, along with application 15/5853N for which we have commented in parallel, seeks to undertake required maintenance and structural works to the Lyceum to ensure the building's ongoing sustainability.

As noted within our other comments, we are supportive of efforts to safeguard and maintain the building as would be achieved through these works. The applicant has set out why these works are required, predominantly because of water ingress into the building and to secure the building's structural integrity. This will involve replacing the theatre's roof (largely covered under 15/5853N), works and repairs to windows which will enable their opening, repointing and general decorations. Internally there are to be basement structural works to alleviate subsidence and to
