**Proposal:** Planning Application - Change of use of land and creation of an earth bund for use as an open air theatre for holding up to 18 events per annum, erection of wooden platform, creation of new vehicular access track and erection of close boarded fence (retention of).

#### Remit:

The Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

#### Comment:

Thank you for consulting the Trust regarding this application which seeks to provide an open air theatre with associated structures at the Star Wing Brewery and Tap Room.

The Tap Room opened in 2019 and is effectively a pub which provides a space for the local community to come together. During its first year it held a range of events including some outdoor performances of Shakespeare's Twelfth Night, thus also helping to draw people into the area and improve access to culture for local people. This proposal seeks to regularise the use of land for the purpose of providing theatre and other such performances and events.

Paragraph 92 of the NPPF (2019) seeks planning decisions to plan positively for community buildings which specifically includes public houses, as well as for culture. Objective SO14 of the Mid Suffolk District Core Strategy (2008) seeks to provide accessible and varied opportunities for leisure and cultural activities in order to promote healthy lifestyles. Saved Policy RT16 of the Local Plan (1998) supports visitor attractions, and we do not consider the nature or scale of this
