**Proposals:** Listed building consent for repair of render, replacement of gutters, replacement of windows, and redecoration of facade to the front elevation

## Remit:

The Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

## Comment:

This application for listed building consent has come to the attention of the Trust because it is seeking to carry out works to the Grand Theatre, specifically repairs and redecoration of the theatre's front facade. It follows an earlier listed building consent for removal of render which was supported by the Trust in March 2021. Those works revealed need for further repairs and replacements, supported by photographic evidence within the Heritage Statement and appraisal reports from specialist contractors.

The need for these works has been well documented; as a statutory listed heritage asset there is clear public benefit in ensuring this important building is safeguarded and maintained.

A new paint scheme with high level hand-painted lettering is also put forward. We are also supportive of these plans, which would update the theatre's appearance in a fashion which is appropriate for a historic building within a conservation area whilst also being of contemporary
