Proposal: Use of two areas of the highway measuring 10.625m X 4.320m for the placing of 11 tables and 22 chairs and an area of 3.035m x .960m for the placing of 1 table and 2 chairs adjacent to the Theatre Royal, Catherine Street. The furniture will be placed on the southeastern end of Catherine Street, along a stretch of the pavement which will, once the tables and chairs are in place, provide for in excess of 2m unobstructed highway

Use of the public highway measuring 10.98m X 1.44m for the placing of 7 tables and 14 chairs adjacent to the Theatre Royal, Catherine Street.

Remit:

The Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment:

Thank you for consulting Theatres Trust regarding this application for the placing of tables and chairs on the highway outside Theatre Royal Drury Lane.

Theatre Royal Drury Lane is a cultural and heritage asset of great significance; it is one of the few theatres in the country to be statutorily Grade I listed reflecting that is of exceptional interest. It is part of the West End's 'Theatreland' cluster of venues which is globally recognised and brings large numbers of visitors into the area. Together they contribute to London's attractiveness as a place to visit.

The theatre has recently re-opened following major refurbishment and has established a substantial 'all-day' food and drink offer. Income from front-of-house sales and ancillary provision is becoming increasingly important in supporting the ongoing sustainability and viability of theatres and other cultural venues. This is especially critical as theatres seek to recover from the pandemic and ongoing uncertainty.

We supported a similar proposal in 2020 at slightly smaller scale which was implemented in 2021. Similarly, we support this proposal. We consider it will help activate Catherine Street and contribute to the character of the public realm without compromising pedestrian movement, the amenity of nearby properties or the significance of the theatre as a heritage asset.
