**Proposal:** Temporary use of the former 'Earls Court Exhibition Centre 2 site', for an operational period from 5th May 2022 until 16th July 2022 and for the temporary erection (not including installation and de-installation) of two event structures - a studio and theatre 'Udderbelly', with two outdoor bars, four food concessions, toilets, storage, outdoor seating areas and fencing, in conjunction with 'Underbelly' Earls Court' Event 2022

#### Remit:

The Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

#### Comment:

Thank you for consulting Theatres Trust regarding this application for temporary planning permission at the Earls Court site. The site would be utilised for Underbelly's 'London Wonderground' event, for which a similar permission was granted in 2021.

Underbelly is an established operator of temporary theatrical and live performance events. This event would be in place between May and July and will include two performance venues with respective capacities of 410 and 80 along with associated facilities and infrastructure, catering, seating areas, signage and fencing. The permission will cover an extended period beforehand and afterwards from mid-April until the end of July for installation and removal.

This event contributes to the strength and diversity of London's cultural offer, as well as enhancing provision for people within the local area. It will also help activate and make use of
