Proposal: OUTLINE APPLICATION (ALL MATTERS RESERVED) FOR DEMOLITION OF EXISTING BUILDING AND REPLACE WITH RESIDENTIAL DEVELOPMENT FOR 20 NO 1&2 BED APARTMENTS AND ASSOCIATED PARKING

Remit:

Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment:

This outline application has come to the attention of the Trust because it seeks demolition of the former Empire Theatre and a replacement residential development. We have not been directly notified. We submitted comments on the previous proposal for this site in January 2016.

The Empire was built as a cine-variety theatre and opened in 1911 as the Empire Palace of Varieties. It was subsequently rebuilt and enlarged in 1937, renaming to the Empire Theatre. Architecturally it is of plain design with corrugated roof and brick walls. The steep slope of its site gave the auditorium greater height than appears from the street and a deep rake, its seating designed on a stadium principle with steeply-stepped rear stalls and a gentler rake to the front. It was equipped with a stage and slightly raised tower. Like many theatres and cinemas it converted to bingo use in the late 1950s but then reverted to a cinema in 1977. Six years later this closed and was then used for storage. It has been vacant and in an increasingly deteriorated state for a number of years.
