**Proposal:** Installation of 1x vertical banner sign, 2x illuminated entrance signs and 1x digital notice board

#### **Remit:**

Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

### Comment:

This application for advertisement consent has come to the attention of the Trust because it is seeking installation of signage at Stanley Arts, formerly Stanley Hall. It is related to a previous listed building consent for external works to which the Trust submitted comments in support.

This proposal relates to signage to the south-west (South Norwood Hill) elevation. Existing signage above two of the doorways will be renewed to reflect the venue's new name and branding. The vertical banner appears to have already been installed. The remaining element is a digital display board which is outlined on the proposed elevation but mis-labelled.

Banners and digital signage of the nature proposed are common additions to theatres and other heritage assets of similar character. These help promote upcoming events and raise awareness of the venue and its offer. Subject to appropriate fixings and wiring these constitute reversible changes.
