Proposals: Erection and display of 2 internally illuminated digital screens located to the front.

Remit:

Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment:

This application for advertisement consent has come to the attention of the Trust because it is seeking to install new digital screens to the theatre's front (southern) elevation next to its main entrance. These would replace existing printed posters.

There have been several applications of this nature for digital screens at theatres across the UK in recent years. They provide operational benefits in that they can be more dynamic and responsive to different audiences and times of day, allowing messages to be tailored for greater effect. They also remove the need and cost of printing and manual change. Show signage and advertisements can in any case be considered an integral element of theatre design and character. Digital screens represent a more modern interpretation of this.

We do not consider that these screens would cause harm to the amenity of nearby properties or give rise to unacceptable implications on highway safety. The frequency of changes and brightness of display can be managed through condition if necessary.

Therefore we are supportive of the granting of advertisement consent.
