The Public Hall is operated by a local charitable trust who took over its running from the Council in 2011. It originally opened in 1894 but was remodelled in the 1930s to add a balcony and orchestra pit. Further works in the 1960s added an extension providing a bar area. The Public Hall can be considered a non-designated heritage asset. It has a mixed theatre and live performance offer including two annual runs of shows by a local amateur group, an annual pantomime, occasional touring theatre productions along with comedy, live music and other events such as an annual beer festival. It is a facility highly valued by local people. Paragraph 93 of the NPPF (2021) seeks planning decisions to plan positively for facilities of this nature.

For the comfort and safety of audiences, performers, staff and other users it is important that venues have sufficient cooling and ventilation. We welcome that the Public Hall's operator is investing in upgrading its facilities in this regard. The proposed units would be installed to the rear of the building's north-west side elevation, broadly adjacent to its stage, and will provide air to the main hall.

The technical data supplied by the applicant suggests that at source the units may exceed background noise levels, and there is some distance from residential properties the neighbouring property as a nursery is also a sensitive receptor. This may require mitigation such as additional enclosure and/or attenuators. If further measures are deemed to be necessary this could be managed through condition.

In principle however, assuming that external sound levels are acceptable or can be made so, we are supportive of the granting of planning permission.
