## Comment:

Thank you for consulting Theatres Trust on this application for change of use of two adjoining railway arches along Albert Embankment to theatre use (Sui Generis).

This proposal is to facilitate an immersive theatre operator which appears to be Parabolic Theatre for a production called 'Bridge Command', based around a journey in a space ship.

The Planning Statement references the loss of theatre use following the withdrawal of Above the Stag in 2022 from two arches nearby. In the short term these plans will reinstate a theatre use within this area, although there is no reference as to the proposed duration this production will be in place and whether the operator intends this as a permanent home. We are supportive of change of use to facilitate this event, which on its own grounds can be supported by policy. Policy ED6.A of the Lambeth Local Plan (2021) promotes use of arches for leisure and community uses and Policy PN2.D specifically encourages cultural and artistic uses within the Vauxhall area. Policy ED13.A promotes arts and cultural uses in the borough, again particularly within Vauxhall.

This is a very different offer to that of Above the Stag who currently remain without a permanent home. This is reflected by the outline plans of proposed internal layout on the air conditioning services plan. Our support for this change of use does not necessarily mean we would support loss of theatre use from arches 72 and 73 without the requisite evidence ordinarily expected.

As set out above, we can recommend the granting of permission for this change of use.
