Thank you for re-consulting Theatres Trust following submission of a revision to plans for the male upper balcony WCs along with further information within an addendum to the Heritage Statement in relation to both the balcony and upper balcony male WCs. granting of listed building consent due to removal of historic cisterns without appropriate justification. Other elements of the scheme – namely works to the balcony female WCs and infilling of windows – we were able to support from the outset.

The addendum now sets out why it is necessary for the cisterns to be replaced in each location, which provides the clear and convincing justification to meet the asks of paragraph 200 of the NPPF (2021). Furthermore one of the cisterns will be retained for re-location and display within the upper balcony WC with an information panel. This further mitigates harm arising from loss of these historic features.

We welcome the applicant's positive approach to concerns raised on this matter not just by ourselves but also Historic England and the West Yorkshire Archaeological Advisory Service, and that they have brought forward a solution which both meets the theatre's audience and operational needs as well as conserving a feature of historic interest on site. We also welcome their commitment to seeing that the rest of the removed cisterns are made available to others for use or re-purposing.

Therefore we can fully support the granting of listed building consent.
