original application in June 2021 which was for a two year period. This will shortly lapse.

The theatre suffers from a lack of internal space, and the accompanying Design & Access Statement sets out that they are seeking a more long-term solution. In the meantime retention of this structure will give the theatre additional working space for administrative functions.

Whilst at the time of our previous comments the need for social distancing was a priority which provided mitigation against the minor impact on setting, enabling the theatre and its staff to work efficiently when internal space is limited is also a benefit. The cabin is located next to other external structures within a less sensitive part of the site.

We therefore support further retention of the portakabin and the granting of temporary planning permission.
