The Trust has been aware of these plans and provided the theatre's operator with advice prior to submission.

Bob Hope Theatre is a valued community theatre which is owned and operated by its members and volunteers. It has an interesting history with the building having been purchased for the community when the Eltham Little Theatre group were threatened with eviction by renowned actor and comedian Bob Hope. It was renamed in his honour. It mostly hosts amateur productions by its own and other local groups as well as community events such as coffee mornings and craft fairs, and occasional live music. Theatres such as this are particularly important for the social and cultural wellbeing of local people, enabling access and participation in theatre and the arts and providing opportunities for people to come together and develop their skills. Paragraph 93 of the NPPF (2021) seeks planning decisions to plan positively these types of facilities.

The outbuilding covered by this application is a garage utilised for storage. It is in poor condition and of no architectural or historic merit, and would be replaced by a new structure of similar size and scale which will be more fit for purpose. It is concealed from public view so would have no impact on the character and setting of the Eltham Palace Conservation Area.

We are therefore supportive of the granting of planning permission.
