The need for these works is that the slate roof has become damaged through slates coming loose and falling resulting in some water ingress. Due to unavailability of slates of the existing dimensions a different sizing will be used, and the opportunity will also be taken to install rooflights to provide natural light to the offices below which will improve working conditions. Thermal efficiency will be improved through installation of a breathable membrane.

We note that other roof works have been carried out previously elsewhere across the building. There is a clear need for these works due to current deficiencies which means the ongoing conservation of this part of the building will be achieved, and furthermore improved insulation and environmental efficiency constitutes a public benefit.

Therefore we are supportive of the granting of listed building consent.
