implementation of Part A. Part C is for completion and submission of historic building recording, and the resulting report is what is being consulted on in this instance.

The consultant carrying out the report shared an original draft with us for comment prior to submission to the Council. This afforded an opportunity to address any shortcomings and ensure the final report was of the standard and detail that would be expected. We are grateful for this opportunity and that our feedback has been positively received resulting in revisions and additional detail and imagery within the document.

We consider that the final report is the best that can be expected under the circumstances and constraints the author had to work within. It is regrettable that the overall content has been compromised by the actions of the Council in stripping so much fabric and not affording an appropriate opportunity to go into the building between works. There could have been an interim stage whereby photographs were taken prior to stripping of the later bingo fit-out. We do not consider the Council to have acted within the spirit of its own planning condition and its approach is not one we have encountered before. We would expect the Council to take formal action to address and remedy what appears to be a breach of condition as it would take against any other applicant.

Nonetheless, within that context we consider the Historic Building Investigation and Recording report to be of sufficient standard to warrant full discharge of Condition 23.
