permission only on a temporary basis for one year to allow for highways impacts to be understood.

Slung Low is an established theatre company with a strong community offer and focus. It operated from the Holbeck Working Men's Club, offering a development and rehearsal space for artists and local groups. It also had a base within a local primary school. Slung Low provide valuable community outreach which is accessible to all, helping people to participate and engage in the arts and to learn and develop new skills. They work with other local and national organisations.

The nature of Slung Low and their work within the community means it is both important and beneficial that their ongoing development and operation is supported. Objective 11 of the Leeds Local Plan, 2019 (as amended) supports provision of community infrastructure that meets the needs of the community including cultural and community facilities. Paragraph 93 of the NPPF (2021) seeks planning decisions to plan positively for community facilities and shared spaces and to support strategies to improve social and cultural wellbeing for all sections of the community.

The applicant has submitted information showing there to be sufficient capacity for parking within the local highway network, and that they endeavour not to programme at times which coincide with high levels of pressure arising from Leeds United home matches.

This location, within Slung Low's direct local catchment, meets the needs of both the organisation and its users. Therefore we are supportive of the granting of planning permission for change of use on a permanent basis.
