This application for listed building consent has come to the attention of Theatres Trust because it seeks the installation of signage at the Noel Coward Theatre.

with a forthcoming run of shows, 'Ocean At The End Of The Lane'. It appears to be a similar submission to a recent application for temporary advertisement consent which was refused on the grounds of being overtly prominent on the streetscape and therefore detracting from the character and appearance of the Covent Garden Conservation Area and harmful to the appearance of the building and visual amenity of the area.

On this occasion the signage will be affixed to hang below the canopy rather than obscuring it. This would appear to positively respond to the previous reasons for refusal.

Show signage can be considered an integral feature of theatre character, altering over time as shows change. There was a similar quantum of signage for this show and in similar positions when it was previously hosted at the Duke of York's Theatre further south along St Martin's Lane. The temporary nature of this proposal means that duration can be controlled by condition and there will be no lasting harm to the character and setting of the theatre as a designated heritage asset.

Therefore we are supportive of the granting of listed building consent.
