plasterwork could be supported but that no Heritage Statement had been made available to justify and describe the works and their impacts.

A Heritage Statement has now been provided. This outlines the necessity for the replacement of the current lighting system, which is because it does not meet the loading requirements of modern systems or current regulations and standards. It also states that any damage will be made good, that a specialist heritage plasterer will be engaged and that new finishes and carpeting will match existing.

We support this approach. It is important that the theatre is able to continue to meet the needs of modern shows and audiences to ensure its ongoing operation and conservation. With reference to paragraph 202 of the NPPF (2023) this constitutes a public benefit which mitigates harm.

We are therefore now in a position to support the granting of listed building consent.
