The Design and Access Statement/Heritage Statement contains photographs and details of deficiencies across both of the theatre's facades. There is a need to address these issues to prevent further deterioration and to help preserve the longer-term conservation of this important heritage asset. This will see like-for-like repairs and replacements carried out across various locations.

There will also be high pressure steam cleaning to remove general dirt which may be concealing further areas in need of attention. Further structural inspections will be carried out during these works.

We welcome the applicant's approach. Whilst there may be some loss of elements of historic fabric in heritage terms this is necessary to ensure the wider conservation and continued operation of the theatre, as well as enhancing public safety.

We therefore support the granting of listed building consent.
