

Signage of similar proportion has been in place at this location previously, and was present when visited by Theatres Trust recently. As noted within the applicant's submission, digital signage of a similar nature is in place at several other theatres around the country. Show signage is in any case a common feature of theatre and live performance venues and can be considered an integral element of their design and character.

On that basis we do not consider that this proposal would give rise to unacceptable impacts on highway safety or visual amenity. Brightness levels and frequency of change can be managed by condition if necessary.

We therefore support the granting of advertisement consent.
