## Six 'Theatres at Risk' get a helping hand from Theatres Trust

A total of £90,000 worth of support awarded as part of the new Theatres at Risk Capacity Building Programme

Theatres Trust, the national advisory body for theatre, has announced the six theatres that will receive support through the first round of its Theatres at Risk Capacity Building Programme:

- Burnley Empire
- Morecambe Winter Gardens
- Peterborough New Theatre
- Salford Victoria
- Spilsby Theatre
- Swindon Mechanics' Institute

The programme is designed to support theatres on the Trust's **Theatres at Risk Register** to commission expert advice and acquire the skills and knowledge to push forward capital projects to help save their theatres.

This round of funding will support projects ranging from a ceiling void inspection to governance training to viability studies. The theatres are all on the Theatres at Risk Register 2019 but are at various stages in their journey to restoration and revival.

**Musician, actor and Theatres Trust Trustee Gary Kemp** says "We know how difficult it can be for theatres to raise funding for the early stage concept and viability works and for organisational support. These first stages of a project provide the vital foundations for both project and organisation, and we hope that with this support, these theatres will be able to make real progress."

Theatres at Risk Capacity Building Programme is supported by Historic England, The Pilgrim Trust, Swire Charitable Trust and individual donors.

Full details of the grants awarded:

**Burnley Empire** will receive £10,000 to cover necessary survey works and for professional expertise from a Construction Design and Management expert commissioned to oversee survey works.

**Morecambe Winter Gardens** will receive £22,000 to cover new governance and training for both the Preservation Trust and the Friends who carry out critical work in maintaining the building, and for business planning support to help create a firm financial footing for the theatre moving forward. The building is on the Historic England Heritage at Risk Register.

**Peterborough New Theatre**, an Art Deco former cinema, will receive £7,500 to fund a ceiling void structural inspection.

**Salford Victoria Theatre** will receive £21,600 to enable the friends group to carry out a viability study for the theatre to determine the optimum viable use for the building. The study will include an options appraisal and high level cost plan for the restoration of the theatre.

**Spilsby Theatre** will receive £5,500 towards a package of works to allow progression to National Lottery Heritage Fund capital works grant, which includes an architectural phasing plan and associated business plan, economic impact assessment, fundraising strategy and heritage activity plan.

**Swindon Mechanics' Institute,** built as a community centre and a concert hall for staff of the Great Western Railway, will receive £23,400 to fund a detailed viability assessment for the Mechanics Institute to determine a preferred viable and beneficial approach to the long-term sustainable use and management of the building. The building is on the Historic England at Heritage at Risk Register.

<u>Theatres Trust</u> is the national advisory public body for theatres. We believe that current and future generations should have access to good quality theatre buildings where they can be

inspired by, and enjoy, live performance. We champion the future of live performance by protecting and supporting excellent theatre buildings which meet the needs of their communities. We do this by providing advice on the design, planning, development and sustainability of theatres, campaigning on behalf of theatres old and new and offering financial assistance through grants.

<u>Theatres at Risk Register</u> is published annually by the Theatres Trust to highlight and support the theatre buildings under threat across the UK. There are 31 theatres on the 2019 list. Every theatre on the register has strong architectural merit or cultural heritage and, the potential to be returned to its original performance use and be a real asset to its community. Since 2006 Theatres Trust has helped save more than 80 theatres on the Theatres at Risk list.
