Proposal: Replacement of the existing fire escape and the erection a temporary escape made from scaffold to be installed whilst works are being carried out.

Remit:

Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment:

This application for listed building consent has come to the attention of the Trust because it is seeking alterations at Brixton Academy for a temporary period whilst an existing fire escape is replaced.

This application is the same as we previously commented on in April 2022 which was subsequently permitted. Condition 3 required the scaffolding to have been removed and land restored to its previous condition before 19th September 2022. It appears that because of contractor availability works were not able to have taken place prior to that deadline.

Therefore our advice remains the same and we similarly support the granting of listed building consent.

We would suggest that on this occasion a condition setting a longer deadline for removal and reinstatement than was the case with the previous consent would be appropriate. This will afford the applicant additional flexibility should availability of contractors continue to present a challenge, avoiding the unnecessary cost, resource and uncertainty of again having to submit a
