Proposal: Alterations to Empress Ballroom Balcony bar including extension of existing bar to include accessible counter, removal of existing bar header, removal of roller shutters over original windows, reconstruction of missing window frame to be infilled with mirrors, replacement of carpet with a wooden floor, and reconfiguration of back of house area.

Remit:

Theatres Trust is the national advisory public body for theatres. We were established through the Theatres Trust Act 1976 'to promote the better protection of theatres' and provide statutory planning advice on theatre buildings and theatre use in England through The Town and Country Planning (Development Management Procedure) (England) Order 2015, requiring the Trust to be consulted by local authorities on planning applications which include 'development involving any land on which there is a theatre'.

Comment:

Thank you for consulting Theatres Trust on this application for listed building consent at the Winter Gardens, in relation to alterations to the Balcony Bar within the Empress Ballroom. We have also been consulted on two further applications to which we have responded under separate cover.

The Balcony Bar is currently inefficient due to its layout and does not meet current standards of accessibility. It is a later intervention, having been installed in the 1970s, and we agree with the applicant's assertion that it has the feel of a social club servery rather than a bar which contributes to the character and significance of its setting.

These plans will remove the bar's header and extend the counter including lower-level positions to meet accessibility requirements. This will enable quicker and more efficient service which will
