We welcome efforts by theatre owners and operators to invest in the repair and maintenance of their buildings, particularly in this case given the very high significance of the Playhouse as a heritage asset. The Trust has commented on other recent applications in this regard. These works relate to works to windows which are in need of replacement.

The windows affected are to the south-west (Upper Greenside Lane), north-east (Greenside Lane), and south-east (Marshall's Court) elevations. They are in a deteriorated condition and have had previous repairs and elements replaced. A list of specific defects is set out within the Heritage Statement. Some photographic evidence has been provided.

Whilst loss of fabric is regrettable, we concur with the applicant's assessment of these windows being in less sensitive locations and of repair being impractical due to condition and logistical challenges in accessing the windows externally to carry out the works and to undertake ongoing upkeep. We therefore support their approach of installing replacement heritage aluminium frames in these locations which will also improve energy efficiency. In turn we are supportive of the granting of listed building consent.
