

The rationale and benefits of upgrading the theatre's wireless infrastructure have been clearly outlined. There is a general operational and customer service need for functional wifi services, for example to operate sales terminals effectively, for audiences to be able to access and purchase services, and for staff to be able to communicate. Significantly it will also facilitate improved hearing assistance technology and audio captioning.

Whilst there will be some very limited harm arising from additional installations with reference to paragraph 208 of the NPPF (2023) we consider the public benefits of enhancing provision for audiences with hearing and sight impairments as well as general operational improvements mitigates this.

We therefore support the granting of listed building consent.
