## Comment:

Thank you for consulting Theatres Trust on this application for listed building consent at the Dominion Theatre, which seeks to install two banner signs for a temporary three year period.

These banners will add additional signage for the forthcoming production of 'The Devil Wears Prada' alongside that already consented, for which we submitted comments of support earlier in 2024. They will extend down both flanks of the theatre's front elevation.

As noted in our previous comments there has been signage in this location covering the front elevation historically. This proposal is reversible and its time-limited nature means there would be no permanent harm to the building's setting. Nevertheless prominent show signage is a recognisable feature of the character and distinctiveness of theatre buildings and other places of live performance and entertainment.

We therefore support the granting of listed building consent.
