Comment:


This application for listed building consent has come to the attention of Theatres Trust because it is seeking to undertake alteration within the stalls at the Pavilion Theatre, specifically to install a ramp to provide wheelchair accessibility.

The Pavilion Theatre is part of the Grade II listing of the pier and is historically and culturally significant as one of the very few remaining pier theatres. The pier was completed in 1862 and the Pavilion was built in 1926. It is designed in a European Kursaal style with an oval domed entrance block with engaged columns with vases above the entablature. The auditorium is oval shaped with a semi-circular proscenium on the long side. It has a mixed programme of theatre, live music, comedy, cinema and other events. It is an important cultural facility for the town. Paragraph 97 of the NPPF (2023) seeks planning decisions to plan positively for facilities such as this.

Currently wheelchair accessibility within the stalls is inadequate, which diminishes the theatre's value as a community asset because it lacks inclusivity. We therefore welcome that the venue is seeking to address this. It will be achieved through inserting a ramp to the front right-hand corner of the auditorium (stage left). The design approach minimises harm to historic fabric and plan form, nonetheless with reference to paragraph 208 of the NPPF we consider that the less than substantial harm generated is mitigated by the significant public benefit of improving accessibility.

We therefore support the granting of listed building consent.
