each end of the Vauxhall Road and Wilton Road elevations.

The Apollo is a Grade II\* listed heritage asset. The proposed cameras are modest in scale, constituting less than substantial harm. We consider there is minimal impact to setting and significance. With reference to paragraph 208 of the NPPF (2023), this is also mitigated by improvement to safety and security of the building and the wider area. Furthermore the proposed intervention is reversible.

We therefore support the granting of listed building consent.
