The Mayflower Theatre is a Grade II listed heritage asset, designed by W. and T.R. Milburn. It is the largest theatre in the south of England outside of London. After being adapted to a cinema in the 1940s, Southampton City Council purchased the building after its closure in the 1980s and leased it at a peppercorn rate to a charitable trust who reverted it back to a theatre. It became a success, attracting big names and notable touring West End shows. The theatre is an important cultural venue for the city, attracting visitors from a wider catchment into the city as well as helping to meet the cultural needs of local people. Paragraph 98 of the NPPF seeks planning decisions to plan positively for facilities of this nature. The Mayflower has undergone previous improvement and development, and there is a current scheme for an additional extension to provide new rehearsal/studio spaces and improve back of house functions.

The needs and technical requirements of producers and touring shows have evolved over time and that is reflected by previous adaptions and alterations to the grid. The flying grid no longer provides the optimum loading and standards required for the theatre to remain competitive.

Paragraph 4.2 of the Heritage Statement indicates the grid is not unique in its design and form, and the Mayflower is not present on a survey of sensitive backstage equipment undertaken in 2009 by Association of British Theatre Technicians for Theatres Trust.

On that basis we raise no objection to the undertaking of this project. It is important for the theatre's ongoing operation and conservation that it is able to attract the shows and events which enable it to remain competitive and to meet the needs of its audiences.

We support the granting of listed building consent.
