Comment:

Thank you for consulting Theatres Trust on this application for planning permission at Bradford Playhouse. It seeks to undertake various external works including replacement of windows and doors, stone repairs, repair and replacement of rainwater goods, removal of obsolete lighting and fittings as well as accessibility improvements. A site visit was undertaken at this theatre in December 2024.

Alongside this application there is a further application for roof works including partial replacement and installation of additional insulation. We have responded to that under separate cover.

Bradford Playhouse is an important community theatre. It was founded in 1929 and the current building dates from 1937 after its original site was destroyed by fire two years previous. The theatre was badly damaged by another fire in 1996. Various financial challenges followed and the Playhouse spent a time on Theatres Trust's Theatres at Risk register. It was removed after purchase by a local theatre enthusiast. The Playhouse's auditorium has a capacity of 266 and there is also a bar within the basement and a studio and rehearsal room within the adjoining building. The Playhouse can be considered a non-designated heritage asset and is within the Little Germany Conservation Area. Paragraph 98 of the NPPF (2024) seeks planning decisions to plan positively for facilities of this nature.

This application focuses on the adjoining building at 4 Chapel Street. On our visit this area was observed to be in need of repair and refurbishment. We therefore welcome that a project to address this is being brought forward.

The existing timber window frames will be removed and replaced with powder coated aluminium frames with new more thermally efficient glazing. Whilst we encourage repair and retention as a first priority for reasons of heritage sustainability, there was evidence of these frames being in poor condition. These replacements will improve energy efficiency and help conserve the building into the future by stopping water ingress and other such issues. The front entrance door to this building will also be replaced on a similar basis.

Other general repairs will help ensure this building is conserved into the future.

The application documents also reference internal alterations to provide better accessibility and the addition of accessible WCs. These works do not directly require planning permission, nonetheless these interventions are to be welcomed and supported as it will improve further enhance the theatre's inclusivity and social value.
