# Theatres fit for the **future**

## Comment:

Thank you for consulting Theatres Trust on this application to vary condition 2 of consent references 24/03991/S73 and 22/04228/FUL arising from further amendments to the scheme for refurbishment and extension at Cambridge Arts Theatre. We were aware these revisions would be coming forward following a site visit undertaken in October 2025.

These changes focus on the theatre's roof, specifically the addition of a mansard screen to the flytower, an enclosure around the boiler house, a screen to St Edwards Passage and re-roofing of the plant room. Although the theatre is a designated heritage asset within the Central Conservation Area, the roof is of lesser sensitivity with previous alterations and modern apparatus installed which to a great extent are shielded from view.

The plant room currently has a slate pitched roof but this will be replaced by a felt flat roof with PV panels installed above and a new mansafe access. We have no objection to this general approach which is of low impact in heritage terms, and support efforts to improve energy and environmental sustainability. Paragraph 167 of the NPPF (2024) gives significant weight to supporting such improvements including through the use of PV panels. Operationally this also enables more efficient siting of necessary mechanical equipment.

Similarly, the screen to the St Edwards Passage elevation enables installation of external Air Source Heat Pumps.

The mansard roof screen to the stage-house roof provide an acoustic enclosure for the auditorium air handling units, mitigating their impact. The units are necessary for supporting the theatre's operation and the comfort of audiences, performers and staff.

We consider these amendments to have a neutral impact on character and significance but will help support the theatre's operation and delivery of the rest of the wider masterplan for development and improvement of the theatre.

We therefore support variation of this planning condition.
